The premises, known as Nectar, are a small speciality grocery shop of approximately 45 square metres selling Polish goods imported direct from Poland, comprising particularly ready-packed fresh and smoked meats, catering for a 90% Polish customer base. The Applicant has been running the business for nearly three years, starting in July 2008, and purchased the premises in December 2009. Prior to its use as a grocery shop, there was a business selling televisions. It is in an area of Bourges Boulevard with a number of small retail businesses. The premises were extended at the end of last year, the works completed in December 2010. A former kitchen at the back of the shop was opened up to enlarge the floor area and built on further into the yard at the back of the premises. A separate disabled-compliant w.c. has also been built behind the shop premises. Behind the shop in the back yard there are also two freestanding secured containers, one of them refrigerated, to store food stuffs for sale in the shop. The inside of the shop has been fitted out completely from new including the installation of meat counters, dairy fridge and redecoration. It is a natural progression for the business to provide alcohol for sale for its customers and the intention is to have a small stock of Polish beers and spirits displayed in a beer fridge and a small area of shelving with wine and spirit bottles.

P Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b,c,d,e) (please read guidance note 9)

The business will be run jointly by the two directors of Nectar Food Limited, the DPS Yuriy Zhuravel and his wife Olena Hrabovenska. There will be 3-4 part-time staff working at different times during the week. The business has been running for nearly three years and Mr Zhuravel is also the owner of a similar business in Huntingdon which he has been running for the last year. Mr Zhuravel has been in Peterborough for 12 years. Mr Zhuravel has not experienced any issues involving the four licensing objectives in running his businesses to date but fully appreciates that the sale of alcohol in his shop will incur new responsibilities.

b) The prevention of crime and disorder

A total of eight CCTV cameras are installed inside and outside the premises. The five internal cameras in the shop are shown on the attached plan. There will also be a camera at the back of the premises in the yard overlooking the container storage and there is a garage attached which is shortly to be fitted out for storage as well, which will have its own camera. A new intruder alarm system has been fitted to the premises. The staff will be trained in respect of under-age sales and Mr Zhuravel will devise a policy for staff procedures in this respect, and public information posters will be displayed. Proof of age will be required when any question of attempted under-age purchases arise. Mr Zhuravel is about to install a new digital till which automatically shows a warning to staff for each sale of alcoholic goods.

c) Public safety

See b) above with regard to under-age sales of alcohol. The premises are fully fitted for fire safety and prevention and procedures for maintaining very high hygiene standards are in place. A five star certificate for hygiene was issued in June 2010.

d) The prevention of public nuisance

The alcohol sales policy for the store will include a bar on the sale of alcohol to customers who show any sign of intoxication. Otherwise, see b) above in respect of under-age sales.

e) The protection of children from harm

As stated above, a strict under-age sales policy will be followed by the premises' owners and all staff employed in the business, and a written policy kept to hand in the shop at all times.
