

The premises comprise a shop unit which is part of the Nene Park Trust Lakeside complex which includes meeting rooms, outdoor activities and a licenced restaurant.

The shop has been fitted out with food displays, with the display that will hold the alcohol being farthest from the door and closest to the till area.

The shop will primarily sell local food, which we plan will include local beer, wine and spirits. Our customers will be visitors to the park and we expect that most of the alcohol will be bought as gifts – all will be for off premises consumption, although there are picnic tables nearby (50 metres away) in the park.

The shop will complement our other gift shop in Ferry Meadows which is already licenced and will be run by the same team.



M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 9)

Nene Park is a well-run and popular venue with mature and well developed management controls and systems. We are very experienced in dealing with the public, often in large numbers.

b) The prevention of crime and disorder

The premises have and will maintain a comprehensive digital colour CCTV system. All public areas of the licensed premises, including all public entry and exit points, and the surrounding environment will be covered, enabling facial identification of every person entering in any light condition. The CCTV cameras will continually record while the premises are open to the public and recording shall be kept available and unedited for a minimum of 28 days with the date and time stamping. A staff member who is conversant with the operation of the CCTV system will be present on the premises at all times when they are open to the public and will be able to produce/download/ burn CCTV images upon request by a police officer or an authorised officer of the licensing authority. Any footage will be in a format that can be played back on a standard personal computer or standard DVD player. (Where the recording is on a removable medium (ie. compact disc, flash card etc), a safe is provided to store those recording mediums).

The premises licence holder will ensure that a digital CCTV system is fully compliant with the guidance contained in the Information Commissioner's Office (ICO) guidance document (www.informationcommissioner.gov.uk) regarding installation of CCTV is provided at the premises.

All sales of alcohol for consumption off the premises shall be in sealed containers only, and shall not be consumed on the premises.

c) Public safety

Our staff are very experienced in ensuring public safety and we will ensure that all risk assessments are up-to-date and that staff are trained accordingly. Appropriate First Aid equipment and materials are available on the premises and a trained first aider is on site at all times.

A fire risk assessment required under the Regulatory Reform (Fire Safety) Order 2005 (as amended) will be completed and be available for inspection by an authorised officer.

Valid public liability insurance will be kept in force and a copy of the schedule will be displayed at the venue and made available for inspection by an authorised Local Authority or Police Officer on request.

Emergency lighting is installed and regularly maintained.

The premises have a current and satisfactory National Inspection Council (for) Electrical Installation Contracting (N.I.C.E.I.C.) periodic electrical installation report. An inspection is carried out every year.

d) The prevention of public nuisance

The premises licence holder, or a responsible person nominated by them in writing, shall receive and respond to complaints throughout the duration of all licensable activities. These complaints shall be recorded and the records made available to the local authority upon request. Such records shall be retained for a minimum of 2 years.

The premises and immediate surrounding area will be kept clean and free from litter at all times the premises are open to the public.

Given sales are for off premises consumption and that we have no near neighbours, we do not expect any major issues with public nuisance. However, our duty Rangers will, as always, keep a close eye on any drinking in the Park.

Irresponsible drinks promotions will not be permitted.

e) The protection of children from harm

The 'Challenge 25' initiative to prevent sales of alcohol to persons under 18 years of age will be implemented at the premises & signage will be prominently placed within the premises advertising the fact that the premises operate the 'Challenge 25' initiative


